Delivery of Semen:

- b. After receiving full payment, the required semen will be released for shipment.
- c. If the Mare is not in foal after 3 insemination doses by veterinarian another three doses will be released once Stallion Owner have received written attestation by veterinarian.

Transported Semen Only:

- d. It is hereby understood and agreed that the frozen semen shall be shipped only to BEVA approved veterinarians, designated herein by "Customer"

- e. "Customer" agrees to pay all costs related to the transportation of frozen semen.
- f. "Customer" assumes all responsibility for following any regulations or requirements that may be imposed by any Breed Registry or Governmental Department.
- g. "Customer" understands that all mares are required to have an endometrial swab taken 30 days prior to service with negative results cultures by a designated laboratory and certificate returned to "Stallion Owner". In addition if "Mare" has previous reproductive difficulties they may require a uterine biopsy performed with a copy of the result forwarded to "Stallion Owner" for review prior to shipment of semen. Should "Stallion Owner" deem any of the above results as unacceptable the "Customer" may substitute another mare.

Assignability:

The "Customer" shall not have the right to assign any rights or delegate any duties under this Contract" without the prior written consent of "Stallion Owner".

Governing Law:

This "Contract" shall be governed by and construed in accordance with the laws of Norway.
